



# Admissions Tuition Classification Addendum

Residency for tuition classification in the State of Colorado is governed by Colorado Revised Statutes §23-7-101, *et. Seq.* Although an individual may be considered a state resident for voting and other legal purposes after being in the state for a short period of time, the tuition law specifies additional requirements for classification as "in-state" for tuition purposes. Admissions Tuition Classification Addendum forms **may only be submitted prior to the first day of a student's first term of enrollment at Aims Community College.** Any changes after the student's first term of enrollment, require a Petition for In-State Tuition Classification.
